On the next screen, you must choose what type of system you are upgradingCorporate Edition, Standard Edition or Workstation. If you choose Corporate Edition, on following screens, you will be prompted to enter in the path to GoldMine, and the SQL database / SQL login info for the SQL database. No matter what you enter in for the SQL info, the Installer will return an error saying that the database can't be upgraded and to "contact your GoldMine Administrator". I talked to FrontRange support. They confirmed that this happens about 95% of the time an upgrade is attempted. Tony with FrontRange tech support said, that support had opened a dialog with the developer on this issue due to the number of problems they are seeing with the new Installer.</p> <p>The work-around is to pick the option for upgrading a Standard Edition of GoldMine, then point the Installer to the GoldMine folder. The Installer will upgrade the .exe, .dll and related files.
